	Allen, Charley Maidment, Madeleine McNeill, Edward Yates (although as a member of
	Diocesan Synod, Charley will be continuing on the PCC as an ex-officio voting
	member). Stephanie Wren has come to the end of her term and will be standing for re-
	election.

4.0	Discerning Inclusion
4.1	Guiding Statement Document
4.1	4.1.1 In light of their roles on Leadership Team and their involvement with the
	Discerning Inclusion process, it was proposed that the PCC co-opt Siân Steel
	and Rachel Powlesland as voting members of the PCC until the APCM on 18
	May. Lucy Allen proposed and Caroline Jowett-Ive seconded. The majority
	voted in favour, there was 5 abstentions and 1 against.
	voted in lavou, there was o abstentions and T against.
	4.1.2 Guiding Statements
	A letter to the PCC from Chris Thomas regarding the Discerning Inclusion
	process had been shared electronically with the PCC as an item of
	correspondence. This unfortunately was only sent to the PCC a few hours
	before the meeting due to the delay in the chair receiving confirmation from
	Chris Thomas that he definitely wanted it to be shared. The chair discouraged
	discussion about the letter though some comments were made by members.
	Peter Robottom expressed his concern about the voting process for section 5 of
	the Guiding Statements document. Francis Parkinson expressed concern with

the paper as a whole and wished it to be noted that he felt the PCC needed more time to discuss the Guiding Statements prior to voting.

The PCC voted using an electronical voting form and the results were shared with the PCC. There was some confusion with question 5 and Madeleine McNeill and Al Meadows did not realise you could vote for more than one item. **Jema Ball proposed** that Madeline and Alasdair could update their vote on question 5. The majority were in favour, with 3 against and 3 abstaining.

Jema updated the PCC of the outcome of the votes, which were as follows.

## **Eligibility for Leadership Roles**

Option A = 8 in favour Option B = 14 in favour Abstentions = 2 Outcome: Option B, carried by a majority of 14 out of 22 votes.

#### Teaching during public worship

Option A = 7 in favour Option B = 14 in favour Abstentions = 3 Outcome: Option B, carried by a majority of 14 out of 21 votes.

#### Pastoral care and discipleship

Option A = 7 in favour Option B = 15 in favour Abstentions = 2 Outcome: Option B, carried by a majority of 15 out of 22 votes.

#### Ministry with young people

Option A = 6 in favour Option B = 16 in favour Abstentions = 2 Outcome: Option B, carried by a majority of 16 out of 22 votes.

### The Prayers of Love and Faith

5A = 6 in favour 5B = 15 in favour 5C = 10 in favour 5D = 12 in favour 5E = 15 in favour Abstain from all of the above = 1

Outcome: There were 23 possible votes for each of the options 5A-E and therefore options 5B, 5D and 5E were carried by the majority.

In summary, the outcomes of the voting were that the more inclusive statements for each of the first four sections were selected by the majority, and *The Prayers of Love and Faith* were approved for use at St Mary's in public acts of worship, private homes and as stand alone services.

On 16 May there was an emergency PCC vote by correspondence, initiated by Jema in light of new information shared by the Archdeacon of Bristol. This led to one further amendment to revise the wording of the PLF paragraph in the Guiding Statements document to state that clergy at St Mary's will only use *The Prayers* in private homes and stand alone services <u>once this has been permitted by General Synod.</u> Jema Ball proposed the majority voted for this option with 6 abstentions.

	Tony Hughes suggested that the PCC vote on the whole of the Guiding Statements paper including the wording before the voting options. <b>Jema Ball</b> <b>proposed and Tony Hughes seconded</b> that the PCC agree the whole of the guiding statements document. The majority voted in favour with 2 against and 6 abstentions.
4.2	Next steps with the process
	4.2.1 The final version of the Guiding Statements document, following the incorporation of the wording which received a majority of votes in each section will be shared with the PCC before the APCM.
	Jema outlined to the PCC, that she would be updating the wider congregation at the APCM and after the APCM there would be information on the website available regarding the outcomes of the Discerning Inclusion process. There will be links to further resources from the traditional viewpoint and from an affirming viewpoint. There will also be a document about unity and loving disagreement.
	Jema assured the PCC know that she will work really hard to ensure that unity is retained as far as possible, and that any future use of The Prayers of Love and Faith is handled carefully and with respect. Jema also let the PCC know that her door is open, if anyone would like to talk further with her about this subject. Jema also reminded the PCC that these statements are now in place for 3 years.
	Charley Maidment asked if this would affect the ASMA (Avonside Mission Area) group. Both Jema and Sonia expressed their view that this would not affect the ASMA partnership as there are already different perspectives held amongst the clergy and churches, and this hasn't negatively impacted working relationships.

	5.1.1 General Update George and Katie Brett, Lewis Simonds and families are leaving after completing their studies at Trinity College. Charley Maidment is seconded to the Arctic and then Rome.
